Ald. Treis as chair called the meeting to order at 7:45 p.m.

Operator license application of Drew E. Sanders, 3062 N. Oakland Avenue, Milwaukee

Capt. Reit reviewed the applicant's violations. Mr. Sanders stated that anything on his record was in his past, and he has since matured. Ald. Treis asked Mr. Sanders if he disclosed everything on his application, and Mr. Sanders replied yes. Ald. Sullivan advised the applicant of the convictions on his record and asked him why they were not disclosed. Mr. Sanders replied that he did not understand the question. Ald. Birschel pointed out that the applicant failed to answer the question regarding violations on the police form.

Moved by Ald. Grimm, seconded by Ald. Birschel to recommend approval --

Ald. Grimm stated that the applicant tried to be honest by disclosing a conviction that did not appear on the record.

Vote on the motion was – Ayes: 4; Noes: 1 (Treis)

Operator license application of Michelle K. Ellison, 2204 E. Locust Street, Milwaukee

Capt. Reit reviewed the applicant's convictions. Ms. Ellison stated that she did not mean to deny having convictions, and that she rushed to fill out the application.

Moved by Ald. Grimm, seconded by Ald. Sullivan to recommend approval with a 6 month review --

Ald. Sullivan advised Ms. Ellison that it is better to disclose information requested on applications, and that he will vote to approve. Ald. Subotich stated that he has no problem voting to deny Ms. Ellison's application because of her failure to disclose her convictions.

Vote on the motion was – Ayes: 2; Noes: 3 (Birschel, Subotich, Treis). Motion fails.
