Operator license application by Adam C. Podkomorski, 9050 S. York Court, Oak Creek

Mr. Podkomorski was not present. This was the applicant's second request to appear before the Committee.

Moved by Ald. Didier, seconded by Ald. Hanson to recommend denial of operator license due to his failure to appear before the Committee. -6

Operator license application by Kari J. Wojciechowski, 2243 N. 70th Street, Wauwatosa

Ms. Wojciechowski was not present. It was the consensus of the Committee to hold this item to the next meeting.

Operator license application by Alan C. Robinson, 2476 N. Bartlett Ave., Milwaukee

Mr. Robinson was present. Mr. Robinson explained that the charges were from four years ago following his discharge from the military. Since then he has started three businesses and has become a responsible member of society. He has always wanted to be a bartender and knows that he will make responsible decisions in this job. Chief Weber stated that Mr. Robinson has had no charges against him since 2003, and suggested the Committee could recommend approval with a six month review.

Moved by Ald. Ewerdt, seconded by Ald. Hanson to recommend approval of operator license with a 6 month review. -6
