Request for hardship exemption to smoking ban ordinance by Open Hearth Restaurant, 2930 N. 117th Street, Gary Vogel, agent

Mr. Vogel was not present. A. Kesner explained to the Committee that if they were considering denying the request they should make it possible for Mr. Vogel to appear and supply the Committee with the additional financials, therefore holding this item until the next meeting. but if they were going to move forward with this request, Mr. Vogel doesn't need to be there. Ald. Didier requested that Mr. Vogel provide financials for the first quarter of 2007, showing the most up to date sales closest to the request date. Ald. Birschel requested 2004 financials to compare with 2005, 2006 and the first quarter of 2007.
