**“Class A” Liquor License application by Kwik Trip Inc., d/b/a Tobacco Outlet #523, 11712 W. North Avenue, Yvonne McCaffery, agent for the period ending June 30, 2011**

Ms. McCaffery was present. Mr. Schmitz, a representative from Kwik Trip Inc., gave a brief explanation to the committee regarding the name of the business, Tobacco Outlet rather than Kwik Trip. Mr. Schmitz followed with the store’s strongly controlled age restriction policy to insure the committee that anyone even looking to be under the age of 30 would be asked to provide identification.

Capt. Weiss had no objections. Mr. Kesner suggested to the committee that if their recommendation was to approve this license, it should be contingent upon the conditional use approval.
