**LEGISLATION, LICENSING & COMMUNICATIONS COMMITTEE**

Ald. Birschel as Chair called the meeting to order at 7:30 PM

**Held from previous meeting, Operator License application by DeAngelo J. Lawson, 6614 N. 43<sup>rd</sup> Street, Milwaukee, for the period ending June 30, 2011**

Mr. Lawson was not present.

Moved by Ald. Hanson, seconded by Ald. Causier  
to recommend denial of Operator license due to not  
appearing as requested Ayes: 5

Mr. Lawson arrived late and the committee reconsidered his application. Mr. Lawson explained why he didn't disclose all the information on his application. Chief Weber said that the criminal damage was older than five years. Mr. Kesner had no additional comments.
