Ald. Birschel as Chair called the meeting to order at 7:31 p.m.

Extension of Class “B” Beer/Class “B” Liquor License by Hector’s – A Mexican Restaurant, 7118 W. State Street for Thursday, June 17, 2010 from 5:00 p.m. to 10:00 p.m.

The committee reviewed a request by Robert Messinger, agent for Hector’s – A Mexican Restaurant to extend their Class “B” Beer/Class “B” Liquor License to include the parking lot for an event on Thursday, June 17, 2010 from 5:00 p.m. to 10:00 p.m.

Capt. Weiss reported that the police department has not had any problems with Hector’s events.

Sheri St. John, 5025 W. Blue Mound Road, appeared as a representative for Hector’s and offered to answer any questions the committee might have.

The committee reviewed a request for transfer of a Class “B” Beer and Class “B” Liquor License between the old and new owners of the Rosebud Cinema Drafthouse. Mr. Kesner noted that this is the first time a transfer of license is being done as a new procedure for the State of Wisconsin. The new owner will be held to the same standard as the former owner.
