ORDINANCE

AN ORDINANCE AMENDING WAUWATOSA CODE SECTION 11.32.080 TO REQUIRE TWO-HOUR PARKING ON A PORTION OF NORTH 86TH STREET

The Common Council of the City of Wauwatosa do ordain as follows:

Part I. The “86th Street – west side” portion of the Schedule of Streets, and Portions of Section 11.32.080 of the Wauwatosa Code is hereby amended by repealing and recreating that language after the letter designated “(e)” to read as follows:

(e) from the alley north of North Avenue to West Wright Street

Part II. This ordinance shall take effect on and after its date of publication.

ORDINANCE O-11-01

AN ORDINANCE AMENDING WAUWATOSA CODE SECTION 11.32.080 TO COMMENCE THREE HOUR PARKING ON A PORTION OF WEST NORTH AVENUE

The Common Council of the City of Wauwatosa do ordain as follows:

Part I. The “North Avenue – south side” portion of the Schedule of Streets, and Portions subsection of Section 11.32.080 of the Wauwatosa Municipal Code is hereby amended by replacing that section which reads as follows,

“(bb) from North 69th Street to North 70th Street” to read as follows:

“(m) from North 69th Street to North 70th Street”

Part II. This ordinance shall take effect on and after its date of publication.
