Under Wisconsin Statutes 19.85(1)(a) or (g) the Board may adjourn into executive session for purposes of deliberating after a quasi-judicial hearing or to confer with their legal counsel. Subsequent to the executive session, the Board may reconvene in open session for further consideration of other matters on the agenda.
