Ald. Birschel as Chair called the meeting to order at 7:30 p.m.

Class “B” Beer / Class “B Liquor” license extension for Hector’s – A Mexican Restaurant, 7118 W. State Street, for the following events: Cinco de Mayo Celebration, Saturday, May 5th, 2012; Hector’s Anniversary Party, Thursday, June 16th, 2012, and HectorFest, Saturday, September 8th, 2012

The committee reviewed a request by Hector’s – A Mexican Restaurant, 7118 W. State Street for three upcoming events. These events have been held yearly: 1) Cinco de Mayo Celebration, Saturday May 5th all day; 2) Hector’s Anniversary Party, Thursday, June 14th from 6:00 p.m. to 10:00 p.m. with live music; and 3) HectorFest, Saturday, September 8th, from 4:00 p.m. to 10:00 p.m. with live music.

Mr. Kesner noted that he and the police department had no concerns. Their only request was that a cell phone number be provided to the aldermen of the district so Hector’s personnel can be reached in case of an emergency.

Present in favor: Beth Causier, 2185 N. 56th Street, Milwaukee

Ms.Causier, representative for Hector’s, commented that these were yearly events that have been held before with no problems. She gave the committee the phone number of the restaurant manager.

Moved by Ald. Causier, seconded by Ald. Nikceвич to recommend approval of liquor license extensions for all three events:1) Cinco de Mayo Celebration, Saturday, May 5, 2012; 2) Hector’s Anniversary Party, Thursday, June 16, 2012; and 3) HectorFest, Saturday, September 8, 2012 contingent upon providing the aldermen of the district with the cell phone number of a contact person for Hector’s in case of an emergency – 4

Resolution approving a Class “A” Beer / “Class A” Liquor License application by Wal-Mart Stores East, LP, d/b/a Walmart Market #3030, 3850 N. 124th Street, for the period ending June 30, 2012

The committee reviewed a request by Walmart Neighborhood Market for Class “A” Beer / Class “A” Liquor Licenses at their store located at 3850 N. 124th Street.

Mr. Kesner commented that this is a new Walmart Neighborhood Market location. He and the police department had no concerns.

Moved by Ald. Roznowski, seconded by Ald. Nikcevich to recommend approval of the Class "A Beer / Class "A" Liquor License for Wal-Mart Neighborhood Market #3030 located at 3850 N. 124th Street – 4

Class "B" Beer / "Class B" Liquor License application by Cranky Al's LLC, d/b/a Cranky Al's, 6901 W. North Avenue

The committee reviewed a request by Cranky Al's for a Class "B" Beer / Class "B" Liquor License for their restaurant. Mr. Kesner and the police department had no concerns with granting this license.

Present in favor: Susan Brkich, 2408 N. 70th Street

Ms. Brkich commented that they would like to sell beer and liquor in order to have a more competitive edge with their business.

Mr. Kesner noted that they would like to add outdoor seating in addition to the liquor licenses. They have already gotten approval for an encroachment agreement from the Board of Public Works. The outdoor seating would be open until 9:00 p.m.

Moved by Ald. Nikcevich, seconded by Ald. Roznowski to recommend approval of the Class "B" Beer / "Class B" Liquor License application by Cranky Al's LLC, d/b/a Cranky Al's, 6901 W. North Avenue and to include outdoor seating in the description of licensed premises - 4
